



Assistance to link bulk ABNs in RAM

You must complete this form if you're a principal authority and need to link **eight or more** Australian business numbers (ABNs) in Relationship Authorisation Manager (RAM).

For us to process this form, you need:

- a myGovID with at least a Standard identity strength
- to be an eligible principal authority
- to be linking eight or more ABNs.

When completing this form

- Type your answers in each section in English.
- You must list a minimum of eight ABNs.
- To link more than 25 ABNs, you need to complete an additional form.

Once linked, your authorisation for each business is valid for up to 12 months. Before expiry, you'll receive reminders to the email address you used when linking to the business, as well as a notification in RAM to remind you to renew.
